- ↻ 6. Turn right onto MN-107 S/MN-70 E
- ↶ 7. Turn left onto MN-70 E
- ↻ 8. Turn right onto Greeley Rd
- ↑ 9. Continue onto Rush Lake Trail
- ↑ 10. Continue onto Rush Lake Rd
- ↻ 11. Turn right onto the Interstate 35 S ramp

- ↻ 15. Keep right to stay on I-35E S
- ↶ 16. Use the right lane to keep right at the fork, continue on I-94 W and follow signs for Minneapolis
- ↻ 17. Take exit 241A toward Marion St

Take W Kellogg Blvd to your destination

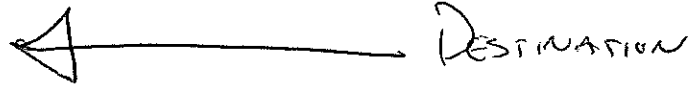
