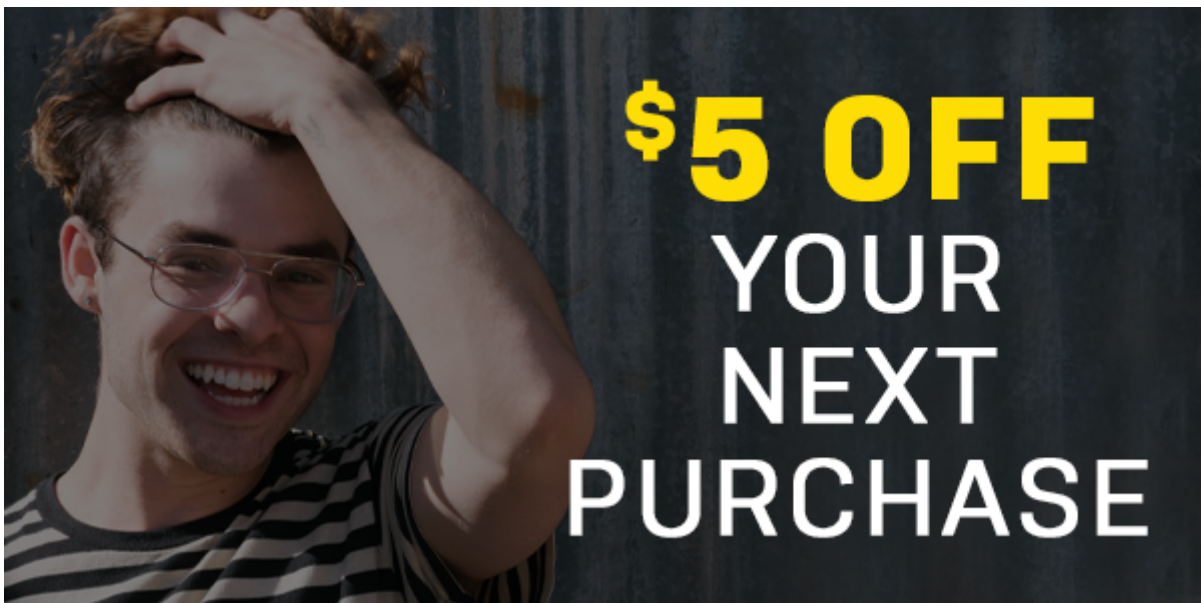

**Stuff you should know:**
