## Refund Policy

TCC offers a return policy for most items purchased directly from TCC through one of its retail stores. Except as provided below, customers may return items purchased at any one of our retail locations for a replacement or refund within fourteen (14) days of the original purchase. All returns and exchanges must be in like new condition with no physical or water damage and must include the following: proof of purchase (store receipt, shipping invoice, or member purchase history), all original components (including device, battery, charger, manual), and in the manufacturer's original packaging. TCC's return policy does not cover ordinary wear and tear or damage caused by improper use or accidents.

Up to \$25 can be returned as cash. All other refunds will be in the form of in store credit or a check sent to the customer's address. If Verizon service is cancelled within 14 days of purchase the customer must return the device to the location before porting the phone number to another carrier. If the number is ported to another carrier before returning the devices to the store location the customer will be charged for the full cost of the device and we will be unable to return the devices in store.

\*\* SD card sales are final and are not eligible for returns, changes or alterations.

## Secondary Agreement

I, as the "Customer" understand and agree that the wireless device(s) purchased in conjunction with a Verizon Wireless Service Agreement receive discounted retail pricing as determined by The Cellular Connection. It is my intention to subscribe to this service for the duration of the agreement I signed with Verizon Wireless. I acknowledge that in the event I terminate my service agreement with Verizon Wireless on or prior to 185 days from the date of this agreement, I will be charged an early cancellation fee of \$400 per device, and I must return all wireless devices to The Cellular Connection ("TCC") location where originally purchased. I acknowledge this amount is a reasonable assessment of the harm to TCC given that such amounts may be hard to calculate due to changing pricing on devices and is not a waiver of additional rights and remedies under law or in equity. For un-returned wireless devices, I will be held liable for the full suggested retail price of each device, less any monies initially paid. I fully understand that these charges are separate from any fees Verizon Wireless may impose for early termination of the service agreement. Further, I also agree to read and abide by all terms and conditions set forth in the Verizon Wireless Customer Agreement. This Early Termination Fee will not apply to service cancellations falling within the standard return policy of 14 days. TCC may elect to waive applicable fees in the event the device(s) is/are returned in good, working condition with no physical damage.
