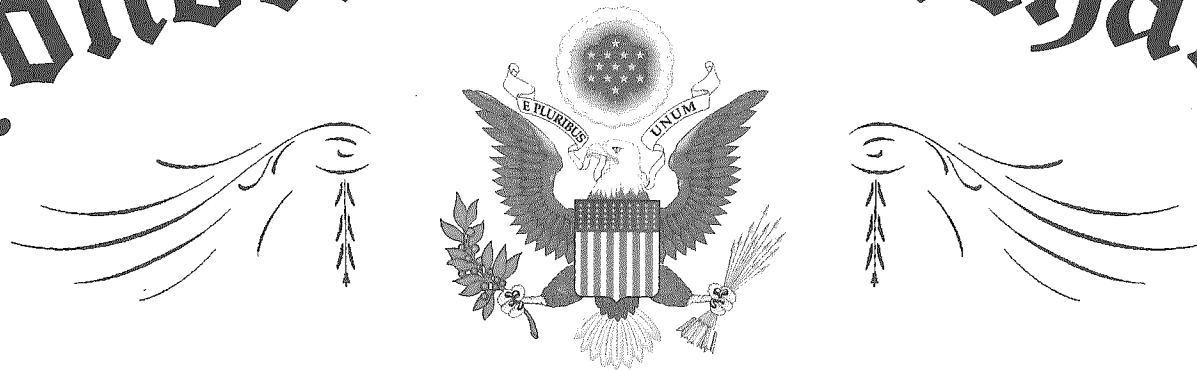
### PRIVACY ACT STATEMENT
